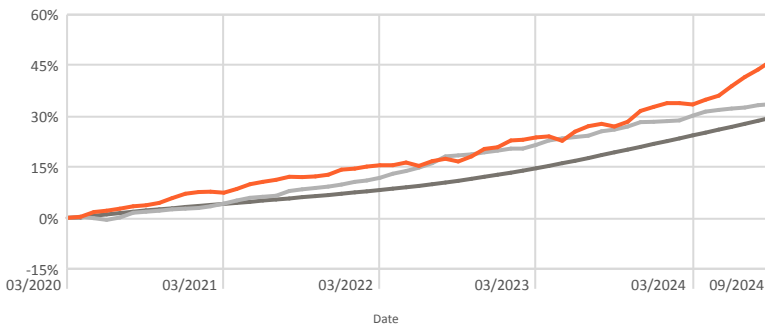
INVESTMENT OBJECTIVE

The objective is to deliver a high level of sustainable income and stability of capital invested.

INVESTMENT POLICY

The Fund is subject to a maximum equity exposure of 10% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property and property related securities, non-equity securities, money market instruments, bonds and other interest bearing instruments and securities.

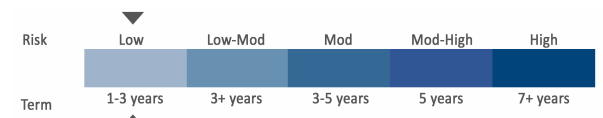
