

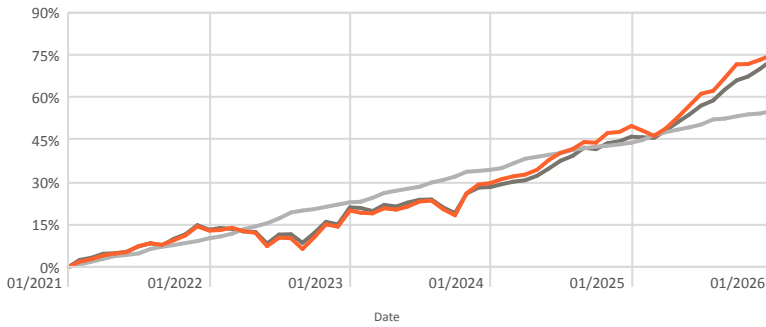
INVESTMENT OBJECTIVE

The objective is to achieve moderate capital growth in the medium to long-term combined with a reasonable level of income.

INVESTMENT POLICY

The net equity exposure ranges between 0% and 60% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property and property related securities, non-equity securities, money market instruments, bonds and other interest bearing instruments and securities.

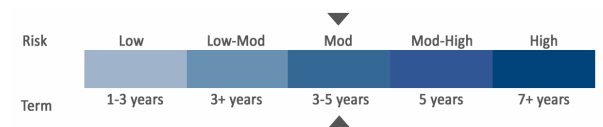

Moderate Risk
