

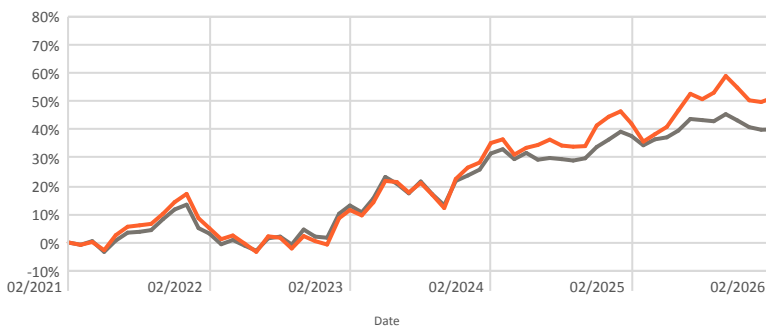
INVESTMENT OBJECTIVE

The objective is to provide investors with long-term capital growth through investment in a diversified range of global asset classes.

INVESTMENT POLICY

The portfolio's offshore exposure will always exceed 80% of its asset value. Investments to be included in the portfolio will, apart from money market instruments and cash, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities.

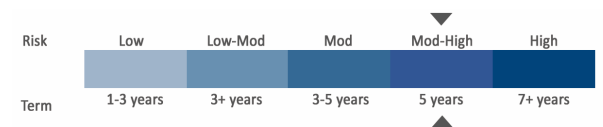

Moderate - High Risk
